Jen Crawford goal to get DOT representation. Spoke with 3 people at DOT:

Mike Shaefer, PE NYSDOT Region 8 Design Engineer and Lynn Weiskopf, NYSDOT Director of the Office of Policy, Planning & Performance both recommended that Sandra Jobson, NYSDOT Region 8 Planning and Programming Manager, participate in our committee. Mike also recommended we generally plan to consult with Greg Hart, NYSDOT Region 8 Rail Coordinator.

MaryAnn Chiffolo, PE, NYSDOT Project Manager of the Rail Projects Group, recommended that we ask Bill Hollister of Amtrak join our committee.

Will also try to reach out to Gregg Hart the Region 8 Rail coordinator

Ellen Jouet-Epstein suggested instead of full time committee attendance, we offer the opportunity for county and state department members to zoom into meetings on an as need basis, thereby increasing the likelihood of increased involvement.

Waterfront "Current" Events

Christina Bohnsack and Jen Crawford –community priorities as gleaned from Scenic Hudson survey conducted January 2020. The Germantown Waterfront committee will review priorities and provide feedback to Scenic Hudson

GERMANTOWN PRIORITIES:

Cheviot north to Ice House Landing and beyond:

Keep access road open between Cheviot and Ernest R. Lasher, Jr. Memorial Park.

Longer term, work with Germantown WAC to create a trail from Cheviot Landing Park northward to the Town-owned waterfront parcel known as Ice House Landing. This is a future Greenway Water Trail Site (HRAP pgs. 121-122).

Germantown Lower Main Street: Create a riverfront park with a low barrier/fencing (details can be discussed with Amtrak/DOT) directing people to cross at an at-grade pedestrian crossing. This park should eventually connect as described above south to Cheviot Park and north to Ernest R. Lasher, Jr. Memorial Park (HRAP pgs. 125-126).

These are not new access points, but rather, fencing/barrier alternatives that municipal officials would like to see in Germantown, Stockport, and Stuyvesant:

• Ernest R. Lasher, Jr. Memorial Park: Context sensitive barriers rather than impasse fencing to keep people away from the tracks (pgs. 131-132).
